Privacy Notice for Schmidt-Itd.uk (Access App) - Human Resources (HR) & Payroll Management System Application. The Access Connect iOS app syncs employee sign-in events with the WebApp when scanning QR codes and NFC cards, transmitting non-identifiable data.

At Schmidt-Itd.uk (Access App), we understand the importance of protecting the privacy of our users. This Privacy Notice explains how we collect, use, and disclose your personal information when you use our Human Resources (HR) & Payroll Management System Application, Schmidt-Itd.uk (Access App).

What Information We Collect
